

MOU AGREEMENT 100 STAMP

Today On the day of 20....., this agreement is being made between **National Institute of Rural Skill Development**, 1-E MB Block ,Laxmi Nagar, Delhi-110092 (herein called Its Party) AND
(Name & Complete Address of the Institute) Herein called Second Party.

WHEREAS, the parties agreed to work for enhancement of Paramedical Education on the term & conditions mentioned below:-

1. Training Centre shall conduct the courses in its present premises which has been inspected and approved. Any change of Premises results automatic cancellation of the approval.
2. Training Centre shall maintain the standard of the courses as per the norms and guidelines issued by time to time and a training Centre is fully bound to comply with order issued NIRSD Delhi is fully bound as regarding syllabus, attendance, examination, result, projects and staff, etc.
3. Minimum 80% attendance must in Theory and 95% in Practical Training. The training Centre should have to do at least one Charitable activity on monthly/two monthly basis.
4. Admissions per batch and per course shall be restricted to the sanctioned intakes and shall not exceed the from approved limit. No forms will be accepted by NIRSD extra then sanctioned courses.
5. That the final/supplementary examination will Conducted by the NIRSD Delhi at the Centre or any other suitable place in the area.
6. NIRSD Delhi shall monitor the standard of the courses regularly by way of feedback received from the participants and visit by NIRSD nominee to assess the standard directly. Such visit will be made at the cost of the approved Centre/Training Centre. Minimum of one visit will be made in respect of each program.
7. Training Centre shall pay the Authorization fee to NIRSD as mentioned in the guidelines. The amount has to be send within a week from the date of commencement of the course to the Secretary, NIRSD Delhi along with the candidate details.
8. Training Centre shall take the responsibility of giving local state / district, agreement of faculty / practical sessions maintain attendance register / follow each and every activity of NIRSD. Advertisement, course to be organized by them. They have to submit monthly report of registered students and this report include attendance sheet (Theory/Practical).
9. It should be very clearly noted that any types of fees/charges once paid, is neither refundable not adjustable in any circumstances. The NIRSD Delhi will not be responsible for any changes in circumstances of training, economic conditions, conflicts or disputes with Management/member/ Centre registered candidate or in any other reason. NIRSD is a unit of National Rural Welfare Foundation which is an Autonomous Organization registered under Trust Act working with motto to 'HEALTHY INDIA'. NIRSD is regd. with NITI Aayog, Approved by Govt. of India under C. R. Act. NIRSD is member of Quality Council of India and An ISO Certified Organization.
10. The approval is for a period of one year only and may be extended based on the progress to be assessed by the NIRSD Delhi. Centre only be extended on the basis of previous year record in which minimum strength of 30 student is of the condition which is compulsory to full fill the Centre for extension of the Centre and also for examination Centre.
11. NIRSD Delhi reserves the right to withdraw the approval given at any point of time, without assigning any reason thereof, in case the NIRSD finds that the Training Centre has deviated from any of the term and conditions.
12. Training Centre shall agree to abide all terms and conditions mentioned above which may be framed by NIRSD Delhi from time to time in order to maintain high standards of training.
13. Prior Approval of of NIRSD will be required for all advertisement given by Centre's and it the Centre fails to do so, it results cancellation of accreditation

14. The Centre will ensure to attach declaration form signed by candidate stating:

- (i) I Know very well that NIRSD is an Autonomous NGO registered under Trust Act and running self-job Oriented courses only for knowledge and wisdom.
- (ii) No Assurance of validity of certificates given by NIRSD or its accredited Centre in Govt./ Private job or in further education.
- (iii) I have taken admission in NIRSD course at its accredited Centre for knowledge only and I will never claim for any type of "Scholarship, Bus Passes and NIRSD accredited Centre never given any guarantee in this regard". Failing to do so enrolment forms of the individual or all student of the Centre will be rejected and also be suspended / cancel Accreditation of the Centre.

If case of any legal dispute, jurisdiction for legal proceedings will be at Delhi only and all disputes will be settled under Mediation or Arbitration Act only.
